- (57) This invention is related to the configuration and assembly method of a boom set, which is a structure for installing attachments, i.e. clamp and bucket on agricultural vehicle. The configuration and assembly method of this boom set consist of a stilt and pins for installing on a boom to function as a boom support with hydraulic cylinder holder and pole holder as components to maintain the part's clearance while assembling.
